

# TrinityBridge Select Fixed Income Fund


#### **Fund objective**

The investment objective of the Fund is to generate income while maintaining its capital value over the medium term (i.e. more than 5 years). The Fund also seeks to maintain a weighted average carbon intensity (tonnes of Scope 1 and 2 CO2 per US\$m of revenue) below a benchmark of the ICE BofA Global Corporate Index, targeting a level 50% below this benchmark by 2030 from 2019 baseline, and net zero by emissions by 2050.

## **Typical investor**

Typical investors in the Fund are looking to generate income without a requirement for capital growth.


